

CHAPTER 4

SCHEDULED FINES

4.01 SCHEDULED FINES. The violation of the following provisions of this Code of Ordinances shall be subject to the scheduled fines provided herein for each offense, plus all applicable court costs and surcharges, except that the scheduled fine shall not apply, and a court appearance shall be required, when a violation involves or results in an accident or injury to property and the total damages are equal to or exceed \$500.00, or in the event of injury to a person, or when the violation created an immediate threat to the safety of other persons or property.
