65.01 THROUGH STREETS - STOP. Every driver of a vehicle shall stop, unless a yield is permitted by this chapter, before entering an intersection with the following designated through streets.

(Code of Iowa, Sec. 321.345)

1. Highway 212;
2. Eastern Avenue;
3. Highway U.S. 6;
4. Court Avenue from Miller Street to North Street;
5. Miller Street from Eastern Avenue to Western Avenue;
6. East Hilton Street from Eastern Avenue east to sale barn property;
7. Western Avenue from Miller Street to Garfield Street;
8. South Street.

65.02 STOP REQUIRED. Every driver of a vehicle shall stop in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. Lafayette Avenue. Vehicles traveling on Lafayette Avenue shall stop at Main Street;
2. Franklyn Avenue. Vehicles traveling on Franklyn Avenue shall stop at Main Street;
3. Hilton Street. Vehicles traveling on Hilton Street shall stop at Marengo Avenue;
4. Franklyn Avenue. Vehicles traveling on Franklyn Avenue shall stop at North Street;
5. Lafayette Avenue. Vehicles traveling on Lafayette Avenue shall stop at North Street;
6. North Street. Vehicles traveling on North Street shall yield at Western Avenue;
7. Roberts Avenue. Vehicles traveling north on Roberts Avenue shall stop at Pine Street;
8. Cherry Street. Vehicles traveling on Cherry Street shall stop at Pine Street;
9. Clinton Avenue. Vehicles traveling on Clinton Avenue shall stop at Main Street;
10. Short Avenue. Vehicles traveling on Short Avenue shall stop at Main Street;
11. Marengo Avenue. Vehicles traveling on Marengo Avenue shall stop at South Street;
12. May Street. Vehicles traveling west on May Street shall stop at Western Avenue;

13. Iowa Valley High School Alley/Parking Lot Access. Vehicle traveling out of the one-way alley parking lot access shall stop at East Washington Street;
14. Dillin Street. Vehicles traveling west on Dillin Street shall stop at Western Avenue;
15. Court Avenue. Vehicles traveling south on Court Ave. shall stop at State Highway 6;
16. South Street. Vehicles travelling north and south on any intersecting avenue to South Street shall be required to stop, with the exception of Western and Eastern Avenue;
17. Franklyn Avenue. Vehicles traveling on Franklyn Avenue shall stop at Lucas Street;
18. Franklyn Avenue. Vehicles traveling on Franklyn Avenue shall stop at May Street;
19. Lafayette Avenue. Vehicles coming out of the Gateway Park Access at Lafayette Avenue shall stop at Garfield Street;
20. Franklyn Avenue. Vehicles traveling on Franklyn Avenue shall stop at West Washington Street.
21. Lafayette Avenue. Vehicles travelling south on Lafayette Avenue shall stop at Lucas Street.
22. Court Avenue. Vehicles traveling north on Court Avenue shall stop at Dillin St.

65.03 FOUR-WAY STOP INTERSECTIONS. Every driver of a vehicle shall stop before entering the following designated four-way stop intersections:

(Code of Iowa, Sec. 321.345)

1. Intersection of Washington Street and Court Avenue;
2. Intersection of Washington Street and Marengo Avenue;
3. Intersection of Hilton Street and Court Avenue;
4. Intersection of Main Street and Marengo Avenue;
5. Intersection of Court Avenue and South Street;
6. Intersection of Court Avenue and Main Street;
7. Intersection of Court Avenue and North Street.
8. Intersection of Court Avenue and May Street.
9. Intersection of Hilton Street and Marengo Avenue.
10. Intersection of Franklyn Avenue and Marion Street.

65.04 YIELD REQUIRED. Every driver of a vehicle shall yield in accordance with the following:

(Code of Iowa, Sec. 321.345)

1. Lafayette Avenue. Vehicles traveling on Lafayette Avenue shall yield at South Street;
2. Lafayette Avenue. Vehicles traveling south on Lafayette Avenue shall yield at Miller Street;
3. Franklyn Avenue. Vehicles traveling on Franklyn Avenue shall yield at South Street;

4. Franklyn Avenue. Vehicles traveling south on Franklyn Avenue shall yield at Miller Street;
5. Court Avenue. Vehicles traveling north on Court Avenue shall yield at North Street;
6. Clinton Avenue. Vehicles traveling on Clinton Avenue shall yield at South Street;
7. Short Avenue. Vehicles traveling on Short Avenue shall yield at South Street;
8. Short Avenue. Vehicles traveling south on Short Avenue shall yield at Miller Street;
9. Short Avenue. Vehicles traveling on Short Avenue shall yield at Marion Street;
10. Jefferson Avenue. Vehicles traveling on Jefferson Avenue shall yield at Marion Street;
11. Wallace Avenue. Vehicles traveling on Wallace Avenue shall yield at Marion Street;
12. Washington Street. Vehicles traveling west on Washington Street shall yield at Western Avenue;
13. Hilton Street. Vehicles traveling east on Hilton Street shall yield at Western Avenue;
14. Marion Street. Vehicles traveling on Marion Street shall yield at Court Avenue;
15. Marion Street. Vehicles traveling on Marion Street shall yield at Western Avenue;
16. Randolph Street. Vehicles traveling on Randolph Street shall yield at Court Avenue;
17. Adams Street. Vehicles traveling on Adams Street shall yield at Court Avenue;
18. Randolph Street. Vehicles traveling on Randolph Street shall yield at Marengo Avenue;
19. Adams Street. Vehicles traveling on Adams Street shall yield at Marengo Avenue;
20. Pine Street. Vehicles traveling on Pine Street shall yield at Marengo Avenue;
21. Marion Street. Vehicles traveling on Marion Street shall yield at Marengo Avenue;
22. Lafayette Avenue. Vehicles traveling on Lafayette Avenue shall yield at West Washington Street;
23. Clinton Avenue. Vehicles traveling on Clinton Avenue shall yield at East Marion Street.

65.05 SCHOOL STOPS. At the following school crossing zones every driver of a vehicle approaching said zone shall bring the vehicle to a full stop at a point ten (10) feet from the approach side of the crosswalk marked by an authorized school stop sign and thereafter proceed in a careful and prudent manner until the vehicle shall have passed through such school crossing zone.

1. Intersection of Clinton Avenue and Hilton Street;
2. Intersection of Short Avenue and Hilton Street;
3. Intersection of Washington Street and Clinton Avenue;
4. Intersection of Washington Street and Short Avenue;

5. Intersection of Court Avenue and Lucas Street.

65.06 STOP BEFORE CROSSING SIDEWALK. The driver of a vehicle emerging from a private roadway, alley, driveway, or building shall stop such vehicle immediately prior to driving onto the sidewalk area and thereafter shall proceed into the sidewalk area only when able to do so without danger to pedestrian traffic and shall yield the right-of-way to any vehicular traffic on the street into which the vehicle is entering.

65.07 STOP WHEN TRAFFIC IS OBSTRUCTED. Notwithstanding any traffic control signal indication to proceed, no driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle.

65.08 YIELD TO PEDESTRIANS IN CROSSWALKS. Where traffic control signals are not in place or in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping, if need be, to yield to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.
