- a) Consideration: FY24 Employee Insurance Benefits Package. Motion by Schlabach to approve changing health insurance to Wellmark BCBS with City contributions adjusting out of pocket expenditures to like or better than current healthcare package, future contract negotiations to be baselined against United Healthcare's current benefits package and to include all employees including 2024 new hires prorated to eligibility date. - b) <u>Discussion: FY25 Budget Status Update.</u> O'Rourke commented the budget processes will change due to property tax levy instead of the max levy. No action.

### **Update Public Works – Lonnie Altenhofen**

The water main work on Lucas St. is complete. The water main work at Industrial Park is near completion. The deconstruction of the old pool is scheduled for next week. The Public Works new hire starts on December 4<sup>th</sup>. Christmas decorations for Jingle Around the Square completed.

### Attorney/ Financial Manager/Administrator Reports

Kensler reported that he will be getting the checks from the City to finalize the easements. O'Rourke commented that Jingle Around the Square preparations are under way. Marck reported that concrete laying for the new pool will start tomorrow.

### Mayor/Council/Committee Reports

Schlabach inquired about the hospital bids for old pool demolition.
